

## Non-Availability of No Objection Certificate of State Government for CBSE

Dear Educators,

Compliments of the Season!

The schools which applied to CBSE board for affiliation from 8<sup>th</sup> July 2013 to 31<sup>st</sup> December 2016 may not have obtained the No Objection Certificate of State Government for CBSE as the Circular of CBSE CBSE/AFF./Circular/2013/10/581277 dated 08.07.2013 about amendment in affiliation Bye-laws Rule 3.3(1) chapter 11-reg. very specifically mentioned that,

Consequent upon recommendations of the Affiliation Committee made in its meeting held on 24.06.2013 and subsequently approval of the Governing Body of the Board in its meeting held on 28.06.2013, the following amendment in affiliation Bye-laws of the Board has been made by the Board:

The school seeking provisional affiliation with the Board must have formal prior Recognition of the state/U.T Govt. and also to produce evidence to this effect that the applicant school had intimated to the concerned Education Department of the State about the application made to CBSE for seeking affiliation with the Board, In case, the Board receives any objection during the process of application of the school, the Board may ask the concerned school to produce the No Objection Certificate from the State Government or otherwise it would be assumed that concerned State/UT government has no objection.

CBSE issued one more circular about amendment in affiliation bye-Laws of the board –Rule 3.3(i) CHAPTER II-Reg No.

CBSE/Aff./Circular/7/2016/1182259 Dated: 29.12.2016 which very specifically mentioned that,

Consequent upon the recommendations of Affiliation Committee made at its meetings held on 13.12.2016 and ratified by the Governing Body in its meeting held on 20.12.2016, the following amendment in Affiliation Byelaws has been made by the Board for seeking provisional affiliation by the schools.

The school seeking provisional affiliation with the Board shall submit the following documents

Amended Rule 3.3(i) Chapter II

(a) Formal prior Recognition letter from concerned State Education Department i.e. Recognition for classes I to V required for Middle Class Approval and Recognition for classes I to VIII required for Provisional Affiliation up to Secondary Level AND

(b) No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with CBSE No Objection Certificate once issued to any school will be considered at par even if it prescribed a specific period and /or level unless it is withdrawn. Condition to submit No Objection Certificate will not be applicable to categories of schools stated at Rule 3.1 (i) to (iv) of Affiliation Byelaws of the Board.

The above amendment is applicable for the applications received from 1st January, 2017 for academic session 2018-19 onwards.

This very clearly can be interpreted as the school which applied to CBSE for affiliation from 8<sup>th</sup> July 2013 to 31<sup>st</sup> December 2016 were not required to obtain No Objection Certificate of State Government for obtaining CBSE affiliation.

Consequent upon recommendations of the Affiliation Committee made in its meeting held on 24.06.2013 and subsequently approval of the Governing Body of the Board in its meeting held on 28.06.2013, the following amendment in affiliation Bye-laws of the Board has been made by the Board:"

Existing Rule 3.3 (i) chapter II	Amended Rule 3.3 (i) chapter II
The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T. Govt. Its application either should be forwarded by the State Govt. or there should be a No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with the CBSE. "No Objection Certificate" once issued to any school will be considered at par even if it is prescribed a specific period of 'stage' unless it is withdrawn. Condition of submitting a No Objection Certificate will not be applicable to categories 3.1(i) to (iv)	The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T Govt. and also to produce evidence to this effect that the applicant school had intimated to the concerned Education Department of the State about the application made to CBSE for seeking affiliation with the Board. In case, the Board receives any objection during the process of application of the school, the Board may ask the concerned school to produce the No Objection Certificate from the State Government or otherwise it would be assumed that concerned State/U.T. Government has No objection.
